Charge Account Credit and Payment Policy

Members in good standing and their authorized immediate family members may charge goods and services at the Club as provided by the following rules and regulations:

- 1. AVONDALE HOUSE ACCOUNTS** have a \$500.00 credit limit. **JUNIOR MEMBERSHIPS** have a \$350.00 credit limit. Charges that apply are:
Monthly Golf Dues and Golf Passes, Green Fee, Power Cart Rentals, Driving Range Charges and Restaurant Charges.
You may keep your credit or debit card number on file for payment of restaurant or pro shop purchases. If needed, arrangements may be made in the office to increase your credit limit.
- 2. MEMBERSHIP NUMBERS:** Each member has an assigned membership account number which is printed on ID cards and/or season passes-**ALWAYS use your member ID number and SIGN ALL CHARGE SLIPS.**
KEEP A COPY OF YOUR CHARGE SLIP FOR YOUR RECORDS. Your cooperation will save the Club both time and money in maintaining accurate accounts.
- 3.** Member identification cards are available in the business office upon request.
- 4.** Original charge slips/receipts for prior 2 months are kept in the office and are viewable upon request.
- 5.** Disputed charges or errors shall be reported to the business office immediately so any necessary adjustments can be made.
- 6.** Any account not paid in full by the 10th of the month following your statement is delinquent. A finance charge at the annual rate of 18% (which is computed as a periodic charge of 1 1/2% per month) will be added to all accounts remaining delinquent past 30 days.
- 7.** Accounts **30 days past due** will have charging & golf privileges suspended in the Restaurant and Pro Shop. Your name will be placed on the No Charge list which is posted in the Restaurant and Pro Shop.
- 8.** Stockholders with an undisputed **90-day delinquent** account will receive notice of possible board suspension. If the account is not paid 2 weeks following receipt of notice, their name will be submitted to the Board of Directors to decide whether they should be expelled from membership. Notice of that decision will be sent to the member in writing whom, if expelled, will have all Club privileges, including golf, suspended as provided in the by laws of the corporation.
- 9.** Accounts **120 days past due** will automatically be sent to collections. Debtor will be responsible for all legal and court cost for the collection thereof.
- 10.** Any indebtedness created under this policy and agreement constitutes a first and prior lien on the capital stock of the corporation
- 11.** This policy and agreement may be amended or terminated at any time by the vote of the Board of Directors..

Accounts for Pro Shop merchandise must be established through the Pro Shop and are **Billed by the Golf Professional**.

Green Fees and power cart rentals can be charged in the Pro Shop ,but are **Billed by the Club**.

Basic Rules of Participation:

1. Current Membership card must be used when golfing at Host Club.
2. Tee times must be made by pro shop staff and should be made at least 24 hours in advance.
3. Players must rent cart(s) from the host facility.
4. Charging privileges should be allowed.
5. Guest privileges will be allowed but all other guests not from participating club must pay the existing host club greens fee rate.
6. Players must adhere to all rules at the host facility.
7. The host club will maintain total control of available tee times.
8. Two 18-hole rounds per Member per season.(U.S. courses)
9. Canadian courses 25% discount.
